Sub:- Extension of last date for admission to 3-year Diploma in Architecture/Architectural Assistantship/Interior Design at Architectural Institutions in the country for the academic session 2023-2024 - regarding.

Dear Sir/Madam,

I am directed to state that the Council has been receiving requests from Diploma institutions and their admission authorities in several states and UTs, for extension of last date for admission to 3-year Diploma in Architecture/Architectural Assistantship/Interior Design at institutions in the respective states/UTs, for the academic session 2023-2024, since the admission process, counselling as well as commencement of classes for Diploma programmes have been delayed.

In this regard, I have to inform you that the Competent Authority of the Council of Architecture, upon consideration of these requests, has decided to extend the last date for completing the process of admissions in 3-year Diploma in Architecture/Architectural Assistantship/Interior Design in the states/UTs in the country by **September 30, 2023** for the academic session 2023-2024, as a special case. The classes for Diploma Programmes may commence from **October 3, 2023** onwards.

The State Boards / Institutions shall be required to arrange for extra classes, as may be required, in order to ensure that the Diploma Programmes are imparted as per the Regulations, Norms and directives issued by the Council.

In view of the above, your good offices are requested to kindly direct the concerned to ensure that the admission deadline for Diploma Programmes, are adhered to by all admission authorities and institutions imparting Architecture degree course in your states/UTs.
